Respected Sir,

The XXIII Circle Conference of SNEA Kerala Circle held at Kottayam on 18th and 19th February 2016 resolved the following:-

- 1. To restore Kerala CMTS model dismantled by merging it with SSA by earlier Circle administration. Implement the direction of Corporate office in this regard.
- 2. ERP may be implemented in its letter and spirit. All paper/file work related to ERP should be discontinued from next financial year and redeployment of staff to field units for marketing and field operations.
- 3. Instruction to deploy employees on Sunday should be withdrawn as the decision is not beneficial to our company and also consider the shortage of staff.
- 4. Those who were transferred on long stay during the year 2013 and 2014 may be transferred back to their parent SSA at the earliest.
- 5. RSTC connections denied by the earlier administration to those who are working in outside HQ may be restored back immediately.
- 6. OMCR work at Panampally nagar may be completed on need basis.
- 7. Steps may be initiated to appoint maximum Apprentice under skill development program of MHRD.
- 8. DCRMS implemented in the Circle is not meeting any purpose, hence the continuance of the system may be reviewed.
- 9. Transfer back all office bearers and activists of SNEA for participating in organizational activities.
- 10.Implement the Corporate Office Order No.BSNL/31-1/SR/2014 dtd 17-12-

14 as early as possible.
