Sub:- Antedating of the date of increment, in revised scales of executives to the senior on par with the junior-reg.

In continuation of this office letter of even no.dated 15-10-2009 certain units have raised some doubts on the subject. Clarifications have been sought from Corporate Office and still under correspondence. In the mean time it has been locally decided now to antedate the date of increment of senior to that of junior without restricting the pay to be allowed on such date to the senior on par with the junior. ie The increment of 3% that has been allowed on the existing date of increment to the senior shall be allowed from the date to which the DNI is antedated. However an undertaking from the concerned officer has to be obtained before extending the said benefit and recorded in the Service Book, in the proforma enclosed.

It is onceagain reiterated that the conditions prescribed by Corporate Office are strictly adhered to avoid objections from Audit/DOT at a later date.
