- 2. The promotion is further subject to the conditions that no disciplinary/vigilance case is pending against the executive. In case of any disciplinary/vigilance case of the type referred to in DOP&T OM No.22011/4/91-Estt(A) dated 14.9.92 is pending/contemplated against the executive or some punishment like stoppage of increment etc. is current, he should not be promoted and the matter should be reported to SEA and Vigilance Branch of Corporate Office immediately.
- 3. Before implementation of the order the SSA/Unit must ensure that Presidential Order for absorption of officers in BSNL has been issued and officers to be promoted are working in the grade of AO/Sr.AO on regular basis. In case, the Presidential order is not issued and the officers are not working as AO/Sr.AO on regular basis, the order should not be implemented and the matter should immediately be brought to the notice of this office. Any request for declination of promotion will not be entertained by Administration due to administrative exigencies.
- 4. On promotion to the grade of STS on adhoc basis, the pay of the officers will be fixed as per the promotion policy issued vide OM No.400-61/2004-Pers I dated 18.01.2007 and PAT branch CO BSNL letter No.1-50/2008-PAT(BSNL) dated 5.3.2009 and further orders on the subject modified from time to time.
- 5. The promotion is further subject to the condition that these officers may be reverted at any time due to administrative exigencies.
- 6. The above adhoc STS promotion will not bestow on the officers any claim for regular appointment to the higher grade nor will the service rendered by them in the grade of STS count for the purpose of seniority in the grade or for promotion to the next higher grade.
- 7. The SSA heads are requested to relieve the officer(s) in case of inter-circle/inter SSA transfers, as early as possible without waiting for substitute. Such officer(s) should be reverted to their substantive grade and be struck off from the roll of SSA latest by 15.09.2012(A/N) and accordingly be deemed to have relieved by the SSA on 15.09.2012(A/N).

- 8. TA/TP may be regulated as per the guidelines issued by BSNL, vide letter No.19-27/2002-L&A(Part) dated 15.4.04 modified from time to time.
- 9. Leave if any requested by the officer under transfer, should not be granted under any circumstances by the SSAs where they are working presently without prior permission of this office. The officer can apply for leave to the Competent Authority at the new place of posting, who will sanction the same, if it is justified in the normal course.
- 10. SC/ST candidate included in the promotion list, if any, who have been promoted on the same standard as applied to General candidates are treated as on 'Own Merit' basis as per the extant DOP &T guidelines in OM No.36012/45/2005-Estt(Res) dated 10.08.2010. These candidates are adjusted against OC vacancies in STS grade of Telecom Finance.
- 11. The officers presently working as CAO on local officiating basis should be reverted to the substantive grade and be promoted afresh in compliance with this order after giving break for one day. It is further intimated that the officers who are performing the looking after duties in the higher grade may be reverted to their substantive grade before relief.
- 12. The officer at Sl.No.7 may be reverted on 29.08.2012 A/N and promoted on 31.08.2012 F/N after giving one day break on 30.08.2012. The officer at Sl.No.42(i.e, Sr.AO) may be promoted on 31.08.2012.FIN.
- 13. This issues with the approval of the Competent Authority.
