Before relieving the officer for officiating promotion, it should be ensured that there is no disciplinary/vigilance case pending against them and no punishment is current. It may also be ensured that the station tenure as per BSNL Corporate Office, New Delhi letter No. 3-1/2002-Restg (Pt.II) dt. 5-9-2007 is followed while posting the officers.
