The above arrangements are purely temporary on local officiating basis for a period not exceeding 179 days. The pay of the officers are to be fixed under provisions of FR 22 (1) a (1).

The local officiating promotion is to be effected within a period of 20 days and if they have not taken up the assignment within 20 days, it will be presumed that they have declined the local officiating promotion and they will be debarred from further local officiating promotion for a period of one year. The local officiating promotion is to be effected after ensuring one day duty as TES Group ‘B’ in the new SSA, as per Part-I above.

Before relieving the officers for officiating promotion, it should be ensured that there is no disciplinary/vigilance case pending against them and no punishment is current.

It may be ensured that the station tenure as per BSNL Corporate Office ND letter No. 3-1/2002-Restg(Pt II) dated 5/9/07 is followed while posting the officers. The posting within the SSA/Unit may be made by the Head of SSA/Unit in such a manner that drawal of Daily Allowance is completely eliminated as per the new transfer/promotion policy of the Corporation. If necessary, choice stations may be called for effecting transfers in the parent cadre to the station of posting as officiating DE. In case of officers posted in the same SSA, the station tenure prescribed as per guidelines scheduled be adhered to.
