The above arrangement is purely temporary and local officiating basis for a period not exceeding 90 days. The local officiating promotion is to be effected within a period of 20 days and if any officer does not take up the assignment within 20 days, it will be presumed that the officer has declined the local officiating promotion for a period of one year. The local officiating promotion is to be effected after ensuing one day duty as Executive (STS) in the SSA, as per Part-I above.
