Subject: Requirement of seats from all circles for E2-E3 Upgradation training

ALTTC has been receiving demands for E2 to E3 executive up-gradation related training from various circles. The circle-wise status of total demand received so far is enclosed. The number of executives already trained up to 04-10-08 has also been indicated along with the unutilized seat-capacities.

As per the guidelines under Executive Training policy, such mandatory trainings are to be provided to executives within 2 years of the date of issue of up-gradation orders. As per status enclosed, a total requirement for 13143 seats has been received out of which about 6419 executives have already been trained (up to October 2008). The balance portion of this total demand, as enclosed, is likely to be covered by June, 2009 by suitable adjustments of training capacities as per directions of BSNL CO. It is reiterated that for scheduling the training-batches, ALTTC depends on the requirements received from the circles and allots seats on First-come-First-serve basis according to the dates on which the requirement is projected.

ALTTC has been requesting the circles for projecting their demands, on priority, to help us schedule such training in a timely manner. We have also been requesting the circles to utilize all the seats allotted to them, failing which, it may be difficult to meet the deadline as given by BSNL CO.

All circles are requested to review their requirements, once again on priority. In case some demand is found pending, the same may please be raised, which will be examined for inclusion in training schedules.
