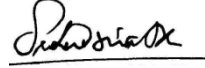
The above arrangement is purely temporary on local officiating basis for a period not exceeding 179 days. The pay of the above officials may be regulated as per **FR 22 I (a) i** and it shall be subject to the out come of WP(C) 23141/2010 and connected cases filed by BSNL before the Hon'ble High Court of Kerala.

The local officiating promotion is to be effected within a period of 20 days and if the officials do not take up the assignment within 20 days, it will be presumed that he/she has declined the local officiating promotion and he/she will be debarred for further officiating promotion for a period of one year. The officials may be reverted automatically on completion of 179th day of officiating or when regular incumbents join, whichever is earlier.

The promotion is also subject to condition that they will have no claim for regular promotion as JTOs and the seniority in the JTO cadre on the basis of having officiated as JTO.

In case any Vigilance/ Disciplinary case is pending/ contemplated against official or any punishment like stoppage of increment is current, the officiating arrangement should not be given effect to and the fact may be intimated to this office immediately.
