Sub:- Promotion of JTOs to the grade of SDE(Telecom) in BSNL
against 67% seniority-cum-fitness quota(Promotion quota).

The JTOs of BSNL, who are promoted as SDE(Telecom) vide BSNL Corporate office letter No.2-15/2009-Pers-II dated 15/5/2009, against 67% seniority-cum - fitness quota (Promotion quota) and allotted to Kerala Circle (enclosed as Annexure) are hereby posted as SDEs(Telecom) from the date they assume charge of the higher post, in the scale of pay of Rs.20600-46500 and posted to the SSAs/Units as noted against each ,with immediate effect provided that,

- 1 They have been absorbed in BSNL on permanent basis;
- 2 .No disciplinary/Vigilance case is pending against him/her and no VC is withheld in terms of instructions contained in GOI (DOP&T) OM No 22011/4/91-Estt(A) 14/9/1992;
3. The currency of any penalty against the officer is over; or
4. The officer is not on deputation to TCIL or any other organization.

BSNL CO will decide such cases as detailed in Para 1 supra on receipt of information from the concerned Telecom Circles. Information in this regard may be brought to the notice of this office immediately and the concerned officer should not be promoted or relieved for posting without specific orders from this office.

The officers are required to join their promotional assignment within a period of 40 days from the date of issue of BSNL Corporate office order.

In case the officer concerned fails to join the promotional assignment within the prescribed period of 40 days from the date of issue of BSNL order, the officer should not be allowed to be retained or joined the post thereafter. In such a case, the promotion order shall become inoperative and the matter shall be reported to this office for intimating the Corporate office. Furthermore no request for modification of promotion order shall be entertained after the expiry of 40 days period.

Leave if any requested by the officer who has been posted on promotion to different SSA should not be allowed. In case the officer desires leave, it has to be applied to the new head of the SSA, only after joining the new post.

Compliance may be reported regarding the date of joining of the officers.

The aforesaid promotion order may be treated as provisional and is subject to the outcome in of final decision in any lawsuit(s) pending before any court(s) regarding their regulation of seniority/promotion.

If the officers have completed tenure at present stations, they should not be posted in the present stations.

The particulars of the officers may also please be updated in the HRMS as soon as they join as SDE(T) on the basis of this order.

Necessary charge reports may be furnished to all concerned.
