The above arrangement is purely temporary on local officiating basis for a period not exceeding 179 days. If the officer is already in the upgraded scale as per the Time Bound upgradation policy, there will not be any benefit in the pay and allowances.

The local officiating promotion is to be effected within a period of 20 days and, if any officer has not taken up the assignment within 20 days, it will be presumed that the officer has declined the local officiating promotion and will be debarred from further local officiating promotion for a period of one year. The local officiating promotion is to be effected after ensuing one day duty as TES Group 'B' in the SSA, as per Part-I above.

Before relieving the officer for officiating promotion, it should be ensured that there is no disciplinary/vigilance case pending against them and no punishment is current. It may also be ensured that the station tenure as per BSNL Corporate Office, New Delhi letter No. 3-1/2002-Restg (Pt.II) dt. 5-9-2007 is followed while posting the officers. The posting within the SSA/Unit may be made by the Head of SSA/Unit in such a manner that drawal of Daily Allowance is completely eliminated as per the new transfer/promotion policy of the Corporation. If necessary, choice of station may be called for, for effecting transfers in the parent cadre to the station of posting as officiating DE. In case of officers posted in the same SSA, the station tenure prescribed as per guidelines scheduled be adhered to.
