Sub: Immediate relieving of non relieved SDEs / JTOs from Units who are under orders of transfer – regarding.

It is seen that the certain officers ( SDEs / JTOs) who are under orders of transfer under long stay basis, issued from this office have not been relieved to the transferred unit, ( **list attached** ). Such unrelieved SDEs / JTOs if any, from your unit **may strictly be relieved latest by 31.07.2012 and necessary relieving / joining entries should be made in HRMS.** Except for those cases where there are any specific orders from Circle Office, Trivandrum allowing a specific retention period, all other transfers should be implemented.

The officers should not be retained in the respective SSAs / Units in the absence of any written communication from this office, merely on the plea that representation for retention / cancellation of the orders has been sent to the Circle Office, Trivandrum. Chief General Manager, Kerala Circle has viewed such non relieving cases very seriously. **Accordingly it is directed not to draw salary of such non relieved officers from the month of August, 2012 onwards.** Any further delay in relieving these officers will be treated as deliberate obstruction in administration process and viewed adversely by the Competent Authority.
